FCC Regulations Require Increases to Access Recovery Charge

The ARC (Access Recovery Charge) is a line-item charge on your monthly phone bill that's required by FCC regulations. These regulations went into effect in 2012 and involve a small annual increase for a specified number of years for the customers of rural telephone companies such as ours.

Starting August 1, 2013 the ARC will increase to \$1.00 for residential and single-line business customers and to \$2.00 for multi-line businesses. Please contact us at 402-245-4451 if you have any questions about these changes.
